2.涂布均匀到位，不可外溢。

The brushing shall be even and in place, and shall not overflow.

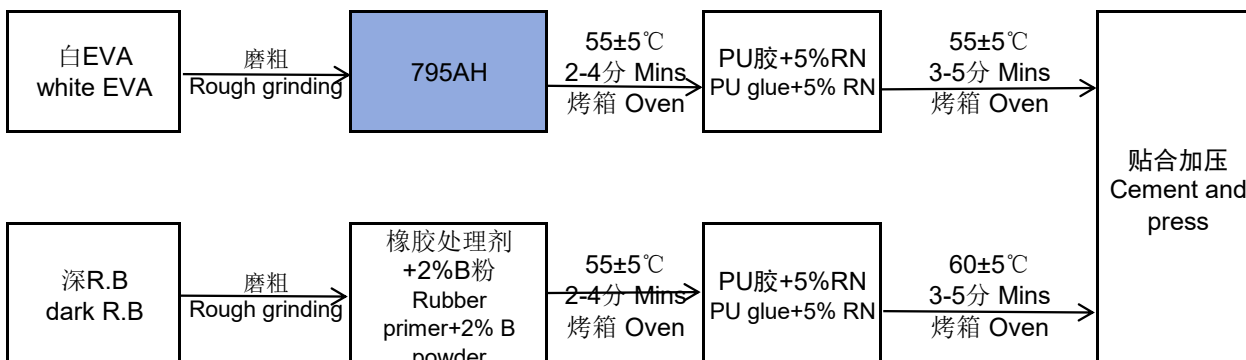
3.硬质EVA材质，深色添加RFE，浅色添加RHE,增强拉力和材质。

Hard EVA material, add RFE for dark material and RHE for light material to enhance materials tension.

4.添加硬化剂调配后，最佳效果2H用完。

After add hardener, please use up within 2 hours.

### 五、注意事项 Attention:

1.准确辨别材质，选用适用的产品。

Accurately identify the material and choose the appropriate products.

2.大量使用前先试胶确认。

Please do the adhesive trial SOP confirmation before mass production.

3.储存于阴凉处，避免阳光直接辐射，适用温度5-35°C.

Store in a shade place, avoid direct sunlight, and keep at a temperature between 5–35°C.

4.该物质内含易燃有机溶剂，远离火源、食品，贮存容器应密封。

This product contains flammable organic solvent. Keep away from fire and food, and ensure the storage container is tightly sealed.

5.上述储存条件下，使用期限6个月，超过储存期，必须经过详细物理测试确认后方可使用。

Under the above storage conditions, the period is 6 months. Beyond the storage period, it can only be used after detailed physical test and confirmation.

6.操作人员须佩戴个人防护用品。

Operators must wear personal protective equipment.
